

**VILLAGE OF THORSBY**  
**BYLAW 2009-02**  
**A BYLAW OF THE VILLAGE OF THORSBY, IN THE PROVINCE OF ALBERTA TO**  
**REPEAL BYLAW 2006-01**

**WHEREAS:** Council passed Bylaw 2006-01 on February 13, 2006 pursuant to Section 658 of the Municipal Government Act, R.S.A. 2000, c. M-26;

**AND WHEREAS:** Pursuant to Bylaw 2006-01, the Village of Thorsby requested that the Registrar of Land Titles cancel the titles to:

**NOW THEREFORE,** the Municipal Council for the Village of Thorsby, in the Province of Alberta, duly assembled, hereby enacts as follows:

1. The Village of Thorsby does hereby order Bylaw 2006-01 repealed.

4. This Bylaw lapses if application to subdivide the said lands has not been made within one (1) year of third reading.
