BY-LAW 94-05-A

BEING A BY-LAW TO ENTER INTO AGREEMENT WITH CANADIAN PACIFIC LIMITED FOR THE ACQUISITION OF AN EASEMENT FROM CANADIAN PACIFIC LIMITED FOR THE PURPOSE OF WATER SUPPLY UPGRADING FOR THE VILLAGE OF THORSBY.

WHEREAS Section 115 of the Municipal Government Act, Revised Statutes of Alberta 1980, Chapter M-26, and amendments thereto, authorizes a municipality to enter into an agreement with a corporation whereby the objectives of the agreement will benefit the Village of Thorsby and its residents:


NOW THEREFORE the Municipal Council of the Village of Thorsby in the Province of Alberta does hereby empower the Mayor and the Municipal Secretary of the Village of Thorsby to enter into an agreement with Canadian Pacific Limited for the purpose of digging, putting down, taking up, relaying, connecting, disconnecting, constructing, repairing, replacing, maintaining, inspecting and operating a waterline trench together with the usual and ordinary appurtenances thereof, such agreement being attached to and forming a part of the By-law.

This by-law takes effect upon the date of the final execution of the agreement with Canadian Pacific Limited.
