

AGREEMENT  
BETWEEN

THE VILLAGE OF THORSBY, IN THE PROVINCE OF ALBERTA

AND

MR. LEON MARYKA OF THORSBY, ALBERTA

For the period of April 1st., 1981 to March 31., 1982

WHEREIN Mr. Leon Maryka agrees to:

1. To pick up the garbage from each individual property within the Village of Thorsby, to a maximum of two (2) approved containers per week for each individual property and deposit the said garbage in a satisfactory manner to the designated garbage disposal grounds operated by Mr. Roman Lichon on the land described as Pt. S.W. ¼ 23-47-1-W5.

and

2. Pick up the said garbage on the same day(s) of each week, the said day(s) to be mutually agreed upon,

and

3. See that all regulations governing the pickup and/or handling of garbage or refuse are adhered to.

In return the Village of Thorsby agrees to the following remuneration schedule:

- 1. Basic pay, effective April 1st., 1981 ..... Monthly \$270.05.
- 2. Plus \$1.46 per pickup for 374 pickups,..... Monthly \$546.04
- 3. Plus \$1.46 per additional pickup effective the 1st., day of October 1981.
- 4. Plus payment for one extra day's collection each Spring and Fall at the then currently weekly rate.

Bylaw 81-4

*Repealed*

Being a Bylaw of the Village of Thorsby, in the Province of Alberta, enabling the Municipal Council to enter into an agreement pertaining to Waste Disposal.

WHEREAS, pursuant to the provisions of Section 194 of the Municipal Government Act being Chapter 246 of the R.S.A., and amendments thereto, the Municipal Council of the Village of Thorsby, in the Province of Alberta, deems it expedient to enter into an agreement for the hauling and disposal of garbage and refuse.

Now therefore, the Council of the Village of Thorsby duly assembled in Council may enact the following:

1 that the Mayor and the Secretary-Treasurer of the Village of Thorsby be and is hereby authorized to enter into and execute an agreement with Mr. Leon Maryka of Thorsby, Alberta for the hauling and disposal of garbage and refuse for the Village of Thorsby.

2. that the said agreement, to be known as Schedule "A" to Bylaw No. 81-4, to be attached and form part of this Bylaw.

3. that all previous bylaws in this regard be rescinded upon the passing of this Bylaw.

This Bylaw shall come into effect upon the day of its finally being passed.
