and,

Whereas, notice of intention of the Council to pass a by-law has been published in the 'Representative' on August 3rd., 1977 and on August 10th., 1977 the last of such publications being at least two weeks before the day fixed for the passing of the by-law,
and,

Wheras, Council was not petitioned for an opportunity to be heard by any person prejudicially affected by the by-law

Now therefore, be it resolved that the Council of the Village of Thorsby does hereby close the following described highway, subject to rights of access granted by other legislation or regulations;

1. The most Southerly 23 ft., in perpendicular width throughout the Unnamed avenue on Plan 1207 T.R. lying East of the production South East of the East boundary of said lot.
2. Second Avenue lying East of the production South East of the West boundary of Block R-11 all on Plan 3473 E.O.
3. Unnamed street adjacent to Lot B, Block 4, Plan 63 H.W. lying East of the production South East of the West boundary of said lot.

This By-law shall come into effect upon the day of its being finally passed.



2. Second Avenue, known municipally as 48th., Avenue, adjacent to Blocks RII and PII as shown on Plan No. 3473 E.C..
3. The Street adjacent to Lot B, Blk. 4 as shown on Plan No. 63 H.W..
