

Being a By-Law of the Village of Thorsby enabling ^{de} Municipal Council to provide for the orderly numbering of houses on lots on the streets and avenues.

Whereas, pursuant to the provisions of Section 171.1 of The Municipal Government Act being Chapter 246 of the R.S.A., and amendments thereto, the Municipal Council of the Village of Thorsby in the Province of Alberta, deems it expedient to pass a by-law for the orderly numbering of houses and lots on the streets and avenues and for the renumbering of them from time to time as Council considers expedient.

Now therefore, the Council of the Village of Thorsby duly assembled in Council hereby enacts as follows:

- 1. That houses and lots in the Village of Thorsby shall be numbered in accordance with the following schedules, commencing with Schedule "A" attached to and forming part of this By-Law and as added thereto from time to time.

This By-Law shall come into effect upon the day of its being finally passed.
